
What is this investment option?

This investment strategy (the "Profile") selected for the policy seeks to create a significant capital appreciation over the long term (which is a factor determining the recommended holding period) through a growth oriented strategy. The level of risk is high. The profile may generate exposure to a variety of financial instruments (bonds, money market instruments and cash, but also equities and alternative investments) issued by European or International entities, directly or indirectly through UCITS and/or UCI funds. However, if the fund selection investment model has been chosen, investments will be limited to those made available by the Insurer and falling within asset categories defined in UK tax legislation. The objective shall be mainly achieved from capital gains and, to a Investment lower extent, from current income. The investment focus is on equities and/or other asset classes representing a higher investment **Objectives:** risk, in addition to fixed-income securities. Part of the Policy assets may be invested in alternative investments. The profile may use risk hedging strategies to reduce the volatility of the underlying assets. The profile may also invest in asset classes representing a higher investment risk. The return from policy assets which are invested in accordance with this profile depends on the performance of the underlying assets which can be positively or negatively influenced by the performance of the financial markets by changes in interest rates, by changes in foreign exchange rates or by any other economic factor. The profile does not guarantee a minimal return and does not offer capital protection.

Intended retail

This profile, when associated with the relevant policy is designed for investor(s) with a high appetite for risk. While the investor(s) are concerned about not getting as much back from the investments as they put in, investor(s) probably also want to make returns on investments. The investors are able to afford high downward fluctuations and losses over the medium to long term. In order to make an investment decision, the investor(s) (i) must have knowledge of, and investment experience in, packaged retail and insurance-based investor: investment products, financial markets and asset class(es) allowed by the profile, and (ii) must understand and evaluate the investment strategy, characteristics and risks associated with the profile.

The risk indicator assumes you keep the investment option for 9 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less. You may not be able to end such investment option easily or may have to end at a price that significantly impacts on how much you get back.

The summary risk indicator is a guide to the level of risk of this investment option. It shows how likely it is that the investment option will lose money because of movements in the markets or because we are not able to pay you.

We have classified this investment option as class 3 out of 7, which is a medium-low risk class. This rates the potential losses from future performance at a medium-low level, and poor market conditions are very unlikely to impact the capacity of the issuer to pay you. Be aware of currency risk. You may receive payments in a different currency, so the final return you will get depends on the exchange rate between

the two currencies. This risk is not considered in the indicator shown above. This investment option does not include any protection from future market performance so you could lose some or all of your investment.

If we are not able to pay you what is owed, you could lose your entire investment.

What you will get from this investment option depends on future market performance. Market developments in the future are uncertain and cannot be accurately predicted. The unfavourable, moderate, and favourable scenarios shown are illustrations using the worst, average, and best performance of the suitable benchmarks over the last 14 years. The figures shown include all the costs of the investment option itself, but may not include all the costs that you pay to your advisor or distributor. - in the first year you would get back the amount that you invested (0 % annual return). For the other holding periods we have assumed the investment option performs as shown in the moderate scenario.

(*) This illustrates how costs reduce your return each year over the holding period. For example, it shows that if you exit at the recommended holding period your average return per year is projected to be 7.9% before costs and 6.3% after costs.
