What is this investment option?

This investment profile related to an internal dedicated fund (the "Fund") of the life insurance product seeks to create a high performance over the long term (which is a factor determining the recommended holding period) in exchange for a substantial exposure to risk. The level of risk is very high. The Fund may be invested in a variety of financial instruments (bonds, money market instruments and cash, but also equities, alternative investments and unquoted assets) issued by European or International entities, directly or indirectly through UCITS and/or UCI funds. The composition and design of the underlying investments will be decided by the Investment Manager, depending on the investment strategy chosen by the Policyholder. The objective shall be mainly achieved from capital gains and, to a lower extent, from current income. The investment focus is on equities and/or other asset classes representing a higher investment risk, in addition to fixed-income securities. Part or all of the Fund may be invested in alternative investments and/or unquoted assets. The Fund may use risk hedging strategies to reduce the volatility of the underlying assets. The Fund may also invest in asset classes representing a higher investment risk. The return of the Fund to which this investment profile is associated to depends on the performance of the underlying assets which can be positively or negatively influenced by the performance of the financial markets by changes in interest rates, by changes in foreign exchange rates or by any other economic factor. It does not guarantee a minimal return and does not offer capital protection.

Objectives:

This Fund is designed for investor(s) with a very high appetite for risk. While the investor(s) are not concerned about getting as much back from the investments as they put in, investor(s) probably also want to make returns on investments. The investors are able to afford very high downward fluctuations and losses over the long term. The risk indicator assumes you keep the investment option for 10 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less. The summary risk indicator is a guide to the level of risk of this investment option. It shows how likely it is that the investment option will lose money because of movements in the markets or because we are not able to pay you.

We have classified this investment option as class 6 out of 7, which is the second-highest risk class. This rates the potential losses from future performance at a medium level, and poor market conditions are very likely to impact the capacity of the issuer to pay you.
