What is this investment option?

Investment Objectives:

This investment profile related to a specialised assurance fund in French: "fonds d'assurance spécialisé", that according to the Circular Letter 15/3 of the Commissariat aux Assurances on investment rules for life assurance products linked to investment fund is an internal fund other than a dedicated fund, directly-linked or otherwise, without a guaranteed return serving as the asset for a single contract (the "Fund") of the life insurance product, that seeks to create a moderate capital growth over the medium to long term (which is a factor determining the recommended holding period) through a balance between security and performance. The level of risk is medium-low. Each asset of a specialised insurance fund is selected directly by the underwriter, either on investment of the initial premium or a subsequent premium, or on execution of a transfer. The Fund may be invested in a variety of financial instruments (bonds, money market instruments and cash, but also equities and alternative investments) issued by European or International entities, directly or indirectly through UCITS and/or UCI funds. The objective shall be achieved from both current income and capital gains. The investment focus is on achieving a balanced exposure to fixed-income securities and equities. Part of the Fund may be invested in alternative investments. The Fund may use risk hedging strategies to reduce the volatility of the underlying assets. The Fund may also invest in asset classes representing a higher investment risk. The return of the Fund to which this Profile is associated to depends on the performance of the underlying assets which can be positively or negatively influenced by the performance of the financial markets by changes in interest rates, by changes in foreign exchange rates or by any other economic factor. It does not guarantee a minimal return and does not offer capital protection.

Intended retail investor:

This Fund is designed for investor(s) with a medium appetite for risk. While the investor(s) are concerned about not getting as much back from the investments as they put in, investor(s) probably also want to make returns on investments. The investors are able to afford downward fluctuations and losses over the medium term. In order to make an investment decision, the investor(s) (i) must have knowledge of, and investment experience in, packaged retail and insurance-based investment products, financial markets and with asset class(es) in which such Fund invests, and (ii) must understand and evaluate the underlying investments, characteristics and risks of the Fund.

What are the risks and what could I get in return?

The risk indicator assumes you keep the investment option for 7 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less. You may not be able to end such investment option easily or may have to end at a price that significantly impacts on how much you get back.

The summary risk indicator is a guide to the level of risk of this investment option. It shows how likely it is that the investment option will lose money because of movements in the markets or because we are not able to pay you.

We have classified this investment option as class 3 out of 7, which is a medium-low risk class. This rates the potential losses from future performance at a medium-low level, and poor market conditions are very unlikely to impact the capacity of the issuer to pay you.

Be aware of currency risk. You may receive payments in a different currency, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

This investment option does not include any protection from future market performance so you could lose some or all of your investment.

If we are not able to pay you what is owed, you could lose your entire investment.

Performance Scenario

What you will get from this investment option depends on future market performance. Market developments in the future are uncertain and cannot be accurately predicted. The unfavourable, moderate, and favourable scenarios shown are illustrations using the worst, average, and best performance of the suitable benchmarks over the last 12 years. Markets could develop very differently in the future.

The figures shown include all the costs of the investment option itself, but may not include all the costs that you pay to your advisor or distributor. The figures do not take into account your personal tax situation, which may also affect how much you get back.

Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the investment option and how well the investment option does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods. We have assumed:

- in the first year you would get back the amount that you invested (0 % annual return). For the other holding periods we have assumed the investment option performs as shown in the moderate scenario.

(*) This illustrates how costs reduce your return each year over the holding period. For example, it shows that if you exit at the recommended holding period your average return per year is projected to be 6.5% before costs and 5.4% after costs. We may share part of the costs with the person selling you the product to cover the services they provide to you. They will inform you of the amount.
