What is the product?

Type: This Product is an investment company qualifying as UCITS Sub-fund in accordance with the UCITS law.

Term: This Product has no maturity date. The Sub-fund has been established for an indefinite period of time. The Board of Directors of the Investment Company is entitled to liquidate, merge or reposition the Product at any time unilaterally in case the Product can no longer be managed in the interest of the investors. The amount the investor will receive upon early termination may be less than the amount invested.

Objectives: This Mixed Sub-fund is actively managed without reference to any benchmark aiming to achieve capital appreciation over the medium to long term by investing in a diversified portfolio of primarily equity and fixed income securities. The Sub-fund promotes environmental, social and governance (ESG) characteristics (within the meaning of Article 8 of Regulation (EU) 2019/2088) through a combination of different portfolio management techniques. Details are available in the prospectus and the ESG website disclosure of the Sub-fund. It mainly invests, either directly or indirectly via shares or units of Target Funds (incl. ETFs - Exchange Traded Funds), in fixed income instruments (min 40% of net assets) such as, but not limited to, money market instruments, government and corporate bonds, inflation linked bonds and floating rate notes as well as in global equities and equity-type securities (up to 60%). The Sub-fund invests without being limited to a specific currency, geographic scope, industrial sector or rating of the issuer; a proportion of the Sub-fund's assets may be invested in Emerging Markets and/or non-investment grade securities. No more than 10% of the Sub-fund can use structured products and derivative instruments to protect against movements in currencies and security prices and for investment purposes. The investor can buy or sell shares on a daily basis (Luxembourg bank business days). This Share Class does not make any distributions. The Sub-fund shall bear the costs of standard charges incurred by the Sub-fund through securities transactions in relation to the portfolio.

Intended Retail Investor: This Product is intended for retail investors with sufficient knowledge and experience in collective investment schemes and similar products, an ability to bear a minor investment loss, and a long-term investment horizon.

What are the risks and what could I get in return?

(A) Summary Risk Indicator



The risk indicator assumes you keep the Product for 5 years. The actual risk can vary significantly if you redeem at an early stage and you may get back less.

The Summary Risk Indicator is a guide to the level of risk of this Product compared to other products. It shows how likely it is that the Product will lose money because of movements in the markets. We have classified this Product as 3 out of 7, which is a medium-low risk class and poor market conditions are unlikely to impact our capacity to pay you. **Be aware of currency risk** if your reference currency differs from the currency of the Product.
