## What is this product?

**Type** | Mandarine Social Leaders is a sub-fund of a SICAV (Société d'Investissement à Capital Variable) under Luxembourg law. Each shareholder has a right of co-ownership in the assets of the SICAV in proportion to the number of shares held.

**Duration** | The UCI was created in 2019 and has an expected lifetime of 99 years.

**Objectives** | Mandarine Social Leaders (the "Fund") is a growth style equity fund comprising listed euro area equities.

The objective of the fund, managed on a discretionary basis, is to outperform its benchmark index, the EURO STOXX® Net Return Index (dividends reinvested), over the recommended investment horizon of five years by selecting companies with above-average growth, earnings and margins and valuation potential via an active stock-picking strategy. The securities are selected in accordance with the management team's convictions. However, the fund's objective is not to replicate the performance of this index in any way.

The Fund will invest at least 75% of its assets in shares of companies which have their registered offices located within the European Economic Area. Within this framework, the Fund will invest predominantly and dynamically in Eurozone equities and, up to a limit of 25% of the net assets, in small-cap equities. The Fund's exposure to the equity market is between 60% and 100%.

The Fund will employ a "Best in Universe" non-financial strategy to select companies with ESG best practices from the investment universe (employee turnover rate, human resources management, diversity in governance, etc.) regardless of their sector of activity. The portion of ESG-rated issuers in the Fund (excluding public debt and cash) will exceed 90% in the long term.

In addition to this non-financial filter, an "owner" non-financial filter is applied. European companies are rated according to an Social Leaders® rating in 5 levels (quintiles) ranging from A (best score) to E (worst score) in order to identify those with a positive social impact in the investment universe.

Accordingly, following the application of these two filters, any company belonging to the first four quintiles of the Best-in-Universe filter, but with an Social Leaders® score of less than 0 on a scale from -2 to +2, will not be

eligible for the portfolio. This is in order to select companies with a positive societal impact from the eligible investment universe.

The Fund may invest up to 25% of its net assets in money market instruments or debt securities and any other type of eligible bond or money market securities. The Fund may also invest up to 10% of its net assets in units or shares of UCIs. Exposure to foreign exchange risk of currencies other than those of the euro area will be secondary.

**Management objective:** To achieve a higher return than that of its benchmark index.

The objective of the Fund is sustainable investment within the meaning of Article 9 of the SFDR Regulation; it is subject to the information publication requirements of the aforementioned Article 9. The Fund is subject to a sustainability risk as defined in the risk profile of the prospectus.

The Fund integrates the performance of the Mandarine Active mutual fund, absorbed on 9 March 2022. The Fund changed its name on 17 November 2022 (formerly: Mandarine Active).

## What are the risks and what could I receive in return?

Risk indicator



The risk indicator assumes that you hold the units for five years.

**Please note:** The actual risk may be very different if you opt for an early exit, and you may receive less in return.

The synthetic risk indicator makes it possible to assess the level of risk of this product in relation to other products. It indicates the likelihood of this product incurring losses in the event of market movements or our inability to pay you.

We have classified the product in risk class 5 out of 7, which is a medium to high risk class. This means that the potential losses associated with the future performance of the product are in the medium to high range and, should the situation on the financial markets deteriorate, it is likely that our ability to pay you will be affected.

What you get out of this product depends on future market performance. The future trend of the market is random and cannot be accurately predicted. The unfavourable, intermediate and favourable scenarios presented represent examples using the best and worst performance, as well as the average performance of the product over the last ten years. ## What happens if Mandarine Gestion is unable to make payments?

Mandarine Gestion is a portfolio management company approved and monitored by the Financial Markets Authority (Autorité des Marchés Financiers) and must comply with organisational and operational rules, particularly with regard to equity. The investor's funds or the income of the UCI are paid into one or more bank accounts opened in the name of the UCI. Consequently, the default of Mandarine Gestion would not have an impact on the assets of the UCI. The UCI does not benefit from a compensation scheme.

## How much will this investment cost me?

You may be asked to pay additional costs by the person selling or advising you about the product. If this is the case, this person will inform you about these costs and show you the impact of these costs on your investment.

### Costs over time (amounts expressed in euro):

The tables show the amounts taken from your investment to cover the different types of costs. These amounts depend on how much you invest, how long you hold the product and how the product performs. We used the following assumptions:

- that in the first year you would get back the amount you invested (0% annual return). that for the other holding periods, the product evolves as indicated in the intermediate scenario.

### How long do I have to keep it and can I withdraw money early?

The recommended investment horizon is a minimum of five years due to the nature of the underlying asset of this investment. The shares of this fund are medium-term investment vehicles and should be acquired with a view to diversifying your assets. You can redeem your shares daily, redemption transactions are executed daily. Holding for less than the recommended period is likely to penalise the investor.
